New Look for the Lobbies

Summer 2009 will bring some quite visible renovations to the Federal Reserve Plaza entrances. The goal of these lobby updates is two-fold. First, we are modernizing the space and giving it a contemporary feel. Second, we are creating enhancements that will help to expedite access for employees and visitors, better meeting our business needs while maintaining our secure environment.

From Start to Finish

The first step will begin in May, with the replacement of the glass walls near the Morris Auditorium with aluminum, matching the rest of the building, as well as new lighting, ceiling and carpet. When the project is complete, the main lobby will have three entrance lanes and a magnetometer on each side for increased ease of access, plus upgraded restrooms and new carpet and furniture in redesigned seating areas. The employee lobby will also be updated, once the main lobby work is complete.

2 Phases for Main Lobby

Like all large projects, the work in the main lobby will be undertaken in stages. **All of the work will be**

done at night and on the weekends, so regular operations will not be impacted beyond some minor adjustments. Work on each side is expected to last 6-8 weeks.

- First you'll see some repositioning of the plants. When work begins on the first phase, on the north tower side, that half of the lobby will be enclosed by temporary walls, and a third magnetometer will be added on the south side to keep employee and visitor entrance traffic flowing.
- When the north side is completed, a temporary wall will be built on the south side, and the work will continue there while the new north side, with its three lanes, is unveiled and begins to take the traffic flow.

Once all of the construction is accomplished, the granite floor will be reconditioned throughout, as will all of the aluminum face. As a final step, new plantings, new carpets and bright new furnishings will be added to create an inviting new threshold for employees and visitors alike.

Spring springing up around the Plaza

Winter is finally fading away, and that means the landscaping crew is gearing up for spring. According to Paul Kelly, Landscaping Supervisor, right now the work is a lot of cleaning out debris and prepping the soil with compost and fertilizer, just as we are doing for our own gardens and lawns. The noticeable work begins in May, when Paul and his crew start selecting the flowering plants for the Roof Garden and around the property. "Quantity, availability and price are the three major considerations," says Paul. "We want a lot of color, and we base our choices on what is bountiful, healthy, and a good value."

As Federal Reserve Plaza pursues LEED certification we are incorporating more organic methods into both the lawn care and in the general landscape. The Landscaping team is also investigating irrigation methods that significantly reduce water consumption.

And for your lawn? We asked for tips from the pro's. Paul says aerate and fertilize now. Your roots will have more oxygen to grow and fertilizing now will yield a thick lawn, which helps to choke out weeds and reduces the need for herbicides. Then top dress your lawn with compost and grass seed, and do your part by using organic alternatives whenever possible!
