It seems extraordinary that the year has passed so quickly and we are again reflecting here on projects past and future. 2009 was another busy year for our team, with hundreds of service calls and several major initiatives undertaken.

We are very pleased to have moved forward so significantly in 2009 on sustainability activities. Our application for Leadership in Energy and Environmental Design (LEED) certification was submitted after several months of effort by our entire building management team. From our craftsmen to our engineers, from the client services team to the space planners, from analysts to interns, everyone played a part in this major initiative, and your willingness to participate is a key element in our success. After a long review process, we expect to have great news in the spring.

The Fitness Center upgrade resulted in a more efficient layout, increased privacy, and improved ventilation. We also had a number of behind-thescenes improvements throughout the building this year which contributed to our sustainability efforts. For example, the garage and secure dock lighting upgrade alone, while improving the quality of the lighting, reduced energy consumption by close to 70,000 kilowatts per year.

The lobby renovations and fire alarm upgrade continue through 2010. You will see further enhancements to our common spaces on the 4th floor this year, and will hear from us about additional sustainability measures. Our commitment remains to keep this the best building in Boston, and among the "greenest," and we appreciate your joining us in this effort.


